TROPICANA JV (IGO 30%) - NEW GOLD DISCOVERY - BEACHCOMBER 1 PROSPECT

 Drilling at the Beachcomber 1 Prospect, located 220 kilometres south-west of the Tropicana Prospect, intersected 4m @ 43.5g/t gold from 24m and 1m @ 1.1g/t gold from 32m (end of hole).

Independence Group NL is pleased to announce the discovery of significant bedrock gold mineralisation at the Beachcomber 1 Prospect, located approximately 220kms south-west of the Tropicana Prospect discovery (**Figure 1**).

AngloGold Ashanti Australia Limited (AGA - Manager) has been undertaking reconnaissance geochemical sampling and drilling to define and test new gold anomalies, as well as continuing to drill test the Tropicana Prospect gold discovery.

Aircore drilling on a 1,000m x 200m grid, testing geochemical anomalies on the southern portion of the joint venture area, returned a number of anomalous results, including the Beachcomber 1 ZSAC0087 intercept. The gold is hosted in weathered quartzo-feldspathic gneiss and results are as follows:

These results are considered very encouraging given the 1,000m x 200m drill spacing and the fact that the hole was vertical and confirm that other gold systems are present in the 12,260km² Joint Venture area, which is considered to be a new Australian Gold Province.

The mineralised intervals will be resampled at 1m intervals and infill drilling is planned once ground clearance surveys have been completed.
