Change of company type, name and replacement of Constitution

At the Annual General Meeting of shareholders held on 20 November 2019 at 4:00pm (AWST) (Meeting), in Perth, Western Australia, shareholders approved the Company be converted from a public no liability company to a public company limited by shares, and approval to change the name of the Company from Independence Group NL to IGO Limited.

ASIC will be notified of the passing of the resolution for the change of company name and type and under subsection 164(3) of the Corporations Act, ASIC is required to publish a notice in the Commonwealth Gazette that states the intention to alter the details of the Company's registration.

The change to the type and name of the Company will come into effect one month after the notice is published in the Commonwealth Gazette. The change of type and name on the ASX will be effective after the change is confirmed by ASIC. The ASX Code for the Company will remain unchanged.

Also, at the Meeting, a new constitution of IGO was adopted by shareholders by special resolution. Changes were required to the constitution in order for the Company to change its status from a public no liability company to a public company limited by shares. The new constitution will come into effect on and from the change of type and name.
